Tile is pure, naturally hygienic, and hypoallergenic — unlike alternative wall and floor coverings, like Luxury Vinyl Tile "LVT", which are manufactured from an array of synthetic materials posing health, replacement, and disposal problems(2), as well as holding a significantly higher Global Warming Potential rating(3).
